This application is for Halton Community Housing Corporation (HCHC) households who want to move from one HCHC unit to another.

Before a tenant can apply for an internal transfer, the following criteria must be met:

The household must be in good standing and may apply for a transfer after it has lived in the unit for at least one (1) year.

A household is in good standing if:

- It has not been issued an eviction notice within the last six (6) months;
- There is no arrears of any type owed to HCHC;
- Rent has been paid on time for the last six (6) months;
- There is no history of damage to the unit or other social concerns (i.e. disturbing neighbours, harassing staff).

Note - Do not use this form if you are applying for any of the following reasons:

Special Priority Policy (SPP) and Terminal Illness Applicants:

Households applying for SPP or Terminal Illness priority are referred to Halton Access to Community Housing (HATCH) for assessment. Please contact 311 or 905-825-6000 to request a HATCH application and appropriate forms. HATCH will update HCHC with the outcome of the application.

Over housed Priority Applicants (RGI only):

Households that have more bedrooms than they are eligible for will be contacted by the Staff to provide details about the requirement to transfer to an appropriate sized unit.

Support Services and/or Accessible Units:

Applicants for support services and/or wheelchair accessible/modified units must apply through Halton Access to Community Housing (HATCH) for the chronological waitlist.

This internal transfer form is for regular priority requests only.

The following request types must apply through Halton Access to Community Housing (HATCH):

- Special Priority Policy (SPP) HATCH will advise HCHC of the outcome
- Support Services Chronological Waitlist
- Wheelchair Accessible/Modified Units Chronological Waitlist
- Properties not owned by HCHC Chronological Waitlist

Over housed households that have more bedrooms than they are eligible for will be contacted by Staff to provide details about the requirement to transfer to an appropriate sized unit.

Applications that would result in splitting a tenancy (i.e. splitting one household into two households) will not be approved.

HCHC limits internal transfer requests for reasons other than SPP or Over Housed, but still provides households with an opportunity to submit a request via this form.

HCHC may make an exception for extenuating circumstances to any regular priority requests, at its sole discretion.

Applicants will receive a decision in writing, advising if their application is approved, or not approved, within 6-8 weeks of the application being received by HCHC.

Approved applicants will receive one (1) offer of housing from the first available unit on the list of properties they selected.

Applicants will be removed from the internal transfer list if they decline one (1) offer of internal transfer. There may be additional implications to RGI subsidy eligibility for over housed households that decline one (1) offer of housing.
